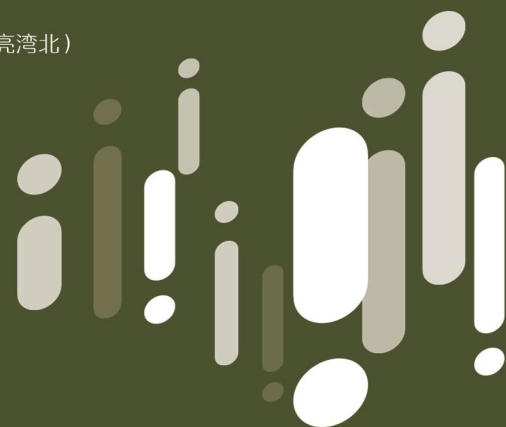

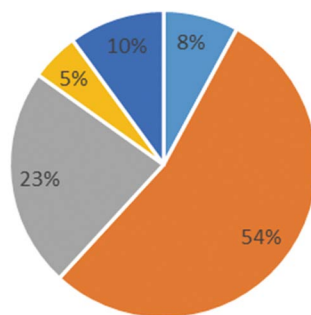

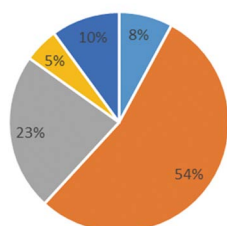
THE EXPECTED SCALE
