

2016 FIPD in preparation

2016 FIPD (Forum for Injection and Packaging Development) will be held early September in Qingdao. It will develop a brand new platform based on the trait of “advanced technology, whole industry chain, and international synchrony”.

Key subjects of 2016 FIPD include manufacturing and application of injection for clinical safety promotion. The purpose is to enrich multi-level interaction of health system by communication between clinic and industry.

Major Topics:

- 1、 Policy interpretation. Discuss the influence caused by 13th Five-Year- Plan on medical industry , agreement evaluation for generic drugs’ quality and efficacy , associated approval for primary pharmaceutical packaging materials with drugs, etc.
- 2、 Information Sharing. Discuss on tidy standardization work, improvement of communication mechanism between clinic and industry, and analysis for the developing trend of injection market.
- 3、 Innovation Exhibition. Gather China and international innovative products, compliance solution and so on. Exhibition is divided into international zone and China zone. Corresponding to forum topics, exhibition emphasizes on injection, infusion device, materials and

containers for injection, facility, raw materials, additives, accessories and medical supplies etc.

- 4、 In-Depth Talk. Invite Chinese and international experts (policy research expert, clinical application expert, technology research expert, market analysis expert etc.) to have in-depth dialogues on hot topics and important events.

FIPD Review

Started in 2006, FIPD is held every two years, with 400 participants and lasting for 2 days. FIPD is a worldwide forum for injection and pharmaceutical packaging, with broad and high level vision. At the same time, FIPD have exhibition zone and special events. About one third of our speakers are international experts. The forum has had simultaneous translation since 2014.

Attendees are from pharmaceutical companies, pharmaceutical packaging companies, hospital, testing agencies, related government, investment agencies, and university etc., and 36% attendees are from pharmaceutical companies.

- In 2008 FIPD, the concept of compatibility study was firstly introduced in China.

- In 2010 FIPD, the toxicological study was focused on.
- In 2012 FIPD, the compatibility study and safety evaluation between injection and pharmaceutical packaging was focused on.
- In 2014 FIPD, the main objective is to guarantee safety for industry chain between infusion and pharmaceutical packaging.
